### **I AM INFORMED THAT:**

- Personal belongings should be labeled with the child's name. We do not allow dangerous objects that may in some way harm another person. Funtopia has the right to take away all items and devices considered dangerous or unnecessary. The items which are taken away will be returned to the parents. It is not allowed children to bring large sums of money. Funtopia is not responsible for lost or stolen money and / or valuables.
- It is not recommended children to use electronic devices (phones, MP3 players, tablets, lasers, etc.) during the day camp. Children must give all electronic devices to their educator/facilitator and receiving them back after the end of the Day camp. Children can use their personnel mobile phones when needed or their parents can connect them by announced phones.
- The Organizer reserves the right to immediately remove a child from the program in the event of physical or verbal abuse, repeated disruptive behavior, or serious disciplinary violations that endanger the safety of the group. In the event of repeated misconduct, the Organizer may refuse the child's participation in future events organized by Funtopia.
- The working time of Funtopia summer day camp is from 8:30 a.m. to 6 p.m. Children should be taken by their parents at the certain working time. In case of delay by the parent/guardian, he/she has to notify us. If the child is taken after 6:15 p.m., the parent should pay an additional fee according to the price list of Funtopia adventure center.
- The photos taken during the Funtopia summer day camp can be used for marketing and promotional purposes like brochures, newsletters, social media publications, videos and any other advertisement materials of the center. Parents who do not want their children to be photographed must submit a written request to the adventure center Funtopia.
- Funtopia Adventure Center does not have a medical practitioner. Its not allowed the staff to give medicines to the children. Our staff is trained to give first aid if needed. In case of a serious injuries or incident, we will immediately contact the parents/guardians mentioned on the registration form.
- Food requests must be made till 5.00 p.m. on the previous day
- The children must carry a book, a bottle of water - marked with his/her name, hat and clothes for changing, swimming set in the days with swimming lessons (swimwear, flip-flops, hat and goggles for swimming, bathrobe)

- In order to use the trampolines zone, you are required to wear appropriate sports outfit as well as special trampolines socks. You can buy them at the reception desk and can reuse them.
- I'm informed that if the kid will not participate in the Funtopia summer day camp, I must notify you on the previous day before 6pm on-duty phone: 0884609060 or 0884013937
- \*If you cannot attend a prepaid visit (daily, weekly or monthly) the visit is not refundable and we don't offer compensation.
- The "Ninja course" is not allowed for children under 120 cm high.
- Signing the Waiver on waiver stations in front of the reception desk is required before registering of my child for a summer day camp.
